Encl: (1) Request to Serve Alcoholic Beverages

- 1. Purpose. Publish procedures for the control of alcoholic beverages within Naval Base Coronado (NBC) and Naval Air Landing Field San Clemente Island (NALF SCI). Per reference (a), "sale, purchase, possession and consumption of alcoholic beverages on Naval installations shall be restricted to personnel 21 years of age and older in all 50 U.S. States and U.S. Territories." Reference (b) issues a general order prohibiting the use or possession of alcohol by persons under the age of 21 on military installations within Navy Region Southwest.
- 2. Cancellation. NASNIINST 1700.17B
- 3. Scope. This instruction constitutes a general order and applies to all personnel attached to NBC, NALF SCI, and tenant commands or activities physically located onboard NBC and NALF SCI. This instruction is punitive in nature and violation of this instruction by service members and civilian personnel may subject the offender to appropriate disciplinary and/or administrative action.
- 4. <u>Definition</u>. "Alcoholic beverage" includes distilled spirits, liquor, wine, beer and other liquids or solids containing these substances that contain one-half of one percent or more either alone or when diluted, mixed or combined with other substances.
- 5. <u>Alc</u>cholic Beverages. The sale, purchase, possession and/or consumption of alcoholic beverages onboard NBC/NALF SCI is

authorized only as specified herein. References (a) through (e) pertain.

- a. <u>Packaged alcoholic beverages</u>. Sale of packaged alcoholic beverages is authorized; in, building 2007 and 244 at NBC buildings 18 and 1017 at NAB; and the Navy Exchange, Building 36, OLF Imperial Beach; and the Ship's store at SCI.
- b. Sale, possession and consumption of alcoholic beverages by the drink is authorized in:
 - (1) The Island Club, Building X, NBC
 - (2) I-Bar, Building I, NBC
 - (3) Pizza Pub/Recreation Center, Building 614, NBC
 - (4) Sea 'n Air Golf Course Club House, Building 800, NBC
 - (5) Bowling Center, Building 772, NBC
 - (6) Salty Crab/Bowling Center, Building 60127, NALF SCI
- (7) Navy Lodge NBC (limited to miniature-sized containers of distilled spirits and wine and individual containers of malt beverages for on-premises possession and consumption in rooms or suites).
 - (8) Breaker's Beach House, Building 764, NBC
 - (9) Chief's Cantina, Building F, NBC
 - (10) Naval Exchange Food Court, Building 2017, NBC
- (11) Any other area designated by the Commanding Officer (CO) for command entertainment or organized social functions on an occasional basis, with prior approval from the CO, NBC. Enclosure (1) shall be used for requests to serve alcoholic beverages at these functions.
- c. Possession and consumption in quarters. Possession and consumption, in moderation, of alcoholic beverages by active duty military personnel 21 years of age and older is authorized in the following places:

- (1) Quarter's rooms and lounges. Use is prohibited in the courtyard.
 - (2) Room configured quarters and cubicles.
- (3) Crew's park during the hours of 1200 2400. Crew's park has been designated a fleet recreational area allowing beer only to be consumed by personnel age 21 and older and not in uniform.

d. Regulations concerning minors

- (1) The sale of any alcoholic beverage to persons under 21 years of age is prohibited.
- (2) Providing, buying, giving or otherwise transferring any alcoholic beverage to persons under 21 years of age is prohibited.
- (3) The possession or consumption of any alcoholic beverage by persons under age 21 is prohibited.
- (4) No person under age 21 shall be employed in any capacity involving the selling or dispensing of alcoholic beverages onboard NBC or NALF SCI.

e. Other prohibitions

- (1) The sale or distribution of alcoholic beverages to intoxicated persons is prohibited.
- (2) Walking with an open container in areas not authorized for consumption of alcoholic beverages is prohibited.
 - (3) Alcoholic beverage vending machines are prohibited.
